## Good Shepherd Fairview Home Visitation Fact Sheet

- Visitors and residents must comply with Social distancing, hand hygiene, and wear disposable face masks at all times. All masks must be discarded upon exiting the grounds.
- Visitors must be screened prior to the visit, including temperature checks.
- <u>Visitors for SNF residents only</u> must have a negative COVID-19 test within 72 hours prior days to the scheduled visit based on CMS positivity rate of >5% and/or upon strong recommendations of the NYS DOH.
- Visitors may opt to schedule an appointment with the facility to receive a Rapid
   Antigen test free of charge. Hours of testing are Monday-Friday 11a.m.-3 p.m. Facility
   is required to report all results to the NYS DOH.
- In-room visitation is limited for residents residing in a shared room. In-room visits in shared rooms can only be accommodated for exceptional reasons.
- Due to the inclement weather of upstate NY, visitation will be allowed inside in a well-ventilated space that will accommodate appropriate social distancing per NYS DOH guidelines. Outdoor visits may commence once weather is appropriate for our residents and families to be outside.
- At no time shall the total number of visitors for our skilled nursing facility exceed 20% of the in-house resident census.
- Visits are by appointment only and are limited to 30 minutes.
- Visitors must be 18 years of age. Any visitor under the age of 16 must be accompanied
   by an adult 18 years of age or older.

- Documentation on visitors first and last name, address, phone, and e-mail is required.
- Good Shepherd reserves the right to refuse any visitor who refuses to be compliant with any aspect of the visitation guidelines or is under the influence, disruptive or presents a danger to any resident or staff.
- Visitation times are:
- Mondays-10 a.m. -12 p.m. and 4p.m. to 6p.m.
- Wednesdays- <u>10a.m.</u> to <u>12 p.m.</u> and <u>4p.m.</u> to <u>6 p.m.</u>
- Thursdays-10 a.m. to 12 p.m.
- Fridays-10 a.m. to 12 p.m. and 4 p.m. to 6 p.m.
- Saturdays- <u>10a.m. 12</u>
- Please call 607-724-2477 Ask for Department of Social Work in SNF and the Case Manager in Assisted Living to schedule visitation
- In the event of any staff and/or resident cases of Covid-19 at the facility, visitation will be suspended until further notice.

**Hand Hygiene:** Whether you use soap and water or hand sanitizer, rub your hands together for at least **20 seconds.** 

Use hand sanitizer if soap and water are unavailable

- 1. Apply the recommended amount of gel to the palm of one hand.
- 2. Cover all surfaces of the hands and fingers.
- 3. Rub the hands together for approximately 20 seconds.

## Proper way to wear mask





Wear a mask that covers your nose and mouth to help protect others in case you're infected with COVID-19 but don't have symptoms

- Wear a mask in public settings when around people who don't live in your household, especially when it may be difficult for you to stay six feet apart
- Wear a mask correctly for maximum protection
- **Don't** put the mask around your neck or up on your forehead
- **Don't** put the mask below your nose or chin.
- **Don't** touch the mask, and, if you do, wash your hands or use hand sanitizer to disinfect
